POOLS WITH 6 COMPETITORS 1<sup>ST</sup> PLACE \$200

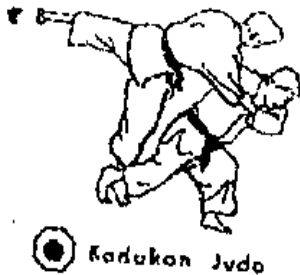

**ELIGIBILITY:** This tournament is open to current members of the USJF, USA Judo, or USJA.

All contestants must present their current membership card and show proof of insurance, at the time of registration. If a contestant is unable to present a current valid membership card, he or she will be required to purchase a membership from one of the three organizations at the tournament site. Responsibility for reimbursement of membership fees for those who have previously registered remains that of the individual.

All contestants must be familiar with the sport of Judo and the rules in connection therewith and have sufficient ability to safely compete in this tournament. Contestants, their parents (in the case of minor contestants), and their instructors have responsibility of ensuring that the contestants meet this requirement.

**CATEGORIES:** A computer program will be used to form pools. Junior divisions will be formed by gender, age, similar weight and rank. Intermediate divisions will be formed by gender, similar weight, age and rank. Senior divisions will be formed by gender, rank and weight. There will be at least four weight divisions for Junior, Intermediate and Senior Divisions. Every effort will be made to separate contestants from the same club and to provide competitors with the maximum number of matches with opponents of roughly the same age, weight and ability, although this will not be possible in all cases. The tournament officials reserve the right to change the priorities in making pools to ensure fair and safe pools for the contestants. Instructors, coaches and parents are also requested to check pools when called to ensure the safety of their students. If a participant decides not to compete after registration but before actual competition, their entry will be withdrawn and the entry fee refunded.

**CONTEST RULES:** Current IJF Contest Rules, with the following modifications:

- No Shime-waza (chokes) ..... Jr. Div (under 13 years)
- No double drop-knee Seoinage ..... Jr. Div (under 13 years)
- No Kansetsu Waza (Joint lock techniques) ..... below Black Belt division
- The CARE system will not be in use
- Pre 2003 IJF medical rule except for the Black Belt Division
- Pre-2009 rules for judogi control will be used in all divisions except for the Black Belt Division
- Pre-2016 rules for wazari awasete ippon. Two wazari awarded to the same competitor will result in ippon and end the match.
- Contest area will be 6 x 6 meters
- Safety areas between contest areas will be 4 meters, outside borders will be 3 meters
- One minute Golden Score for junior divisions

Match time: Senior Black Belts – 4 minutes  
Intermediates, Senior White and Brown Belts – 3 minutes  
Juniors – 2 minutes

Awards: Jr. / Int. / Sr. - points > wins > head-to-head\* > lowest exponent  
Training incentive - wins > points > head-to-head\*.

\* At the discretion of the referee a run-off may be conducted if contestants aren't previously matched.

**AWARDS:** 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place trophies for each pool. Trophies for all participants in non-black belt pools.

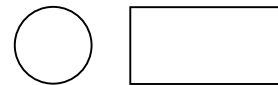
**MISC:** Please wear slippers/shoes when walking off the mat area.

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.

2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.

3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.

4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.
